<p><u>Suicide</u></p> <p>Complainant called 911 to report that her 22 year-old boyfriend was heavily intoxicated and was holding a handgun approximately 30 minutes before her call when she left his apartment. Officers Zieske and Mayberry made entry and located the male subject in the bedroom with a single gunshot to the head.
